By participating, I do not rely upon the expertise of any director, officer, activity coordinator or the agents of any of the foregoing. I agree that I am solely responsible for my personal safety and conduct. Furthermore, I, on behalf of myself, my heirs, executors, successors and assigns, hereby voluntarily release, discharge, waive and relinquish any and all actions or causes of actions for personal injury, property damage or wrongful death rising out of or resulting from my participation in any O&A sponsored activity which have or may have now or in the future against O&A, its officers, directors, activity coordinators, members and agents for any said causes of action whether the same shall arise by the negligence of any of the said persons or otherwise.
